

**MINUTES OF THE PUBLIC HEARING HELD BY THE BOARD OF TRUSTEES OF THE
VILLAGE OF RIVERVIEW, ST. LOUIS COUNTY, MISSOURI, HELD ON
SEPTEMBER 29, 2011.**

BE IT REMEMBERED THAT the Board of Trustees of the Village of Riverview, St. Louis County, Missouri, met at City Hall, 9699 Lilac Drive at 6:00 p.m. on September 29, 2011.

At the time and place, upon roll being called, there were found to be present the following named officers and members of the Board.

Trustee Howard Pierce	Present
Trustee Craig W. Boehmer	Present
Trustee Phyllis Paro	Present
Trustee Bruce Stocker	Absent (but came in late)
Chairman Steve Paro	Present

Village Clerk Madonna Forrest was also present.

There being a quorum present, the meeting was called to order by Chairman Steve Paro in order to discuss establishing the annual rate of tax levy for 2011 for all property within the Village of Riverview. The tax rate schedule for 2011 as prepared by Hochschild, Bloom, & Co. LLC gives the following figures:

.334 per \$100 of assessed valuation on residential property
.294 per \$100 of assessed valuation on commercial property
.312 per \$100 of assessed valuation on personal property

Trustee Howard Pierce noted that the rates for residential and personal property increased, while the rate for commercial property decreased from 2010.

Trustee Bruce Stocker and Trustee Phyllis Paro commented on the change in rates.

None of the residents present made any comment regarding the tax rates.

A motion was made by Trustee Phyllis Paro and seconded by Trustee Bruce Stocker to accept the rates as shown above. All trustees voted in the affirmative, and the motion carried.

BILL 146: AN ORDINANCE ESTABLISHING THE ANNUAL RATE OF TAX LEVY FOR THE YEAR 2011 ON ALL PROPERTY LOCATED WITHIN THE VILLAGE OF RIVERVIEW, MISSOURI

A motion was made by Trustee Craig Boehmer and seconded by Trustee Bruce Stocker to read Bill 146 by title only a first time. All trustees voted in the affirmative, and the motion carried.

BILL 146: AN ORDINANCE ESTABLISHING THE ANNUAL RATE OF TAX LEVY FOR THE YEAR 2011 ON ALL PROPERTY LOCATED WITHIN THE VILLAGE OF RIVERVIEW, MISSOURI

A motion was made by Trustee Phyllis Paro and seconded by Trustee Craig Boehmer to read Bill 146 by title only a second time. All trustees voted in the affirmative, and the motion carried.

BILL 146: AN ORDINANCE ESTABLISHING THE ANNUAL RATE OF TAX LEVY FOR THE YEAR 2011 ON ALL PROPERTY LOCATED WITHIN THE VILLAGE OF RIVERVIEW, MISSOURI

A motion was made by Trustee Bruce Stocker and seconded by Trustee Craig Boehmer to enact Bill 146 as Ordinance 11-22. By roll call vote:

All trustees voted in the affirmative, and the motion carried. Bill 146 becomes Ordinance 11-22 upon being duly signed by the Chairman and attested by the Village Clerk.

With no further business to discuss a motion was made by Trustee Howard Pierce and seconded by Trustee Craig Boehmer to adjourn the meeting. All trustees voted in the affirmative, and the motion carried. The meeting was adjourned at approximately 6:15 pm.
